Purpose of this Agreed-Upon Procedures Report

DECLARATION OF FINAL RESULTS

I hereby declare the final result of the InternetNZ 2023 Council Election, which closed at 12 noon on Wednesday 26 July 2023, as follows:

Election of THREE (3) Councillors to the InternetNZ Council

Total Valid Votes 141
Total Invalid Votes 0
Winning Threshold/Quota 36

After the tallying of all preferences, the successful candidates are Potaua BIASINY-TULE, Kate PEARCE and Stephen JUDD.

The unsuccessful candidates were Norie APE, Jonathan MOSEN and Don STOKES.

The return percentage was 42.22% being 141 votes received from 334 members.
